



TERMS & CONDITIONS

Harbour Town Adelaide Lunar New Year Facebook and Instagram Competition

General

1. Information on how to enter this competition and other details contained in promotional advertisements forms part of the conditions of entry. Entry into this competition constitutes acceptance of these terms.
